Girls on the Run uses running and other physical activities as a vehicle for teaching life skills and promoting health outcomes for 1,032 girls at 62 public, private, and charter schools. Each season, trained volunteer coaches implement the 10-week curriculum through twice-weekly sessions that build character and resilience. The season concludes with a celebratory 5K event, which gives the girls a tangible sense of achievement as well as a framework for setting and achieving life goals.
