Our programs are delivered in elementary and middle schools and community sites throughout Greater Atlanta, Athens and North Georgia. For the 2022-2023 school year, we ambitiously set a program registration goal that reflected pre-pandemic program registration numbers. Although we did not reach our goal, this past school year, 2,658 children participated in our programs on 182 teams. It has been
